Extract from the Terms of Participation A and B

B 3. Co-exhibitors and additionally represented companies

The participation of companies as co-exhibitors/additionally represented companies (cf. A 4) is principally possible. Participation is, however, subject to Messe Muenchen India's prior authorization. Permission to participate may be granted only if the co-exhibitor/additionally represented company would also be eligible to participate as an exhibitor.

The registration fee for each co-exhibitor and any additionally represented company is ₹15,000. This fee is including the minimum catalog/internet entry with company name, hall and stand number.

Co-exhibitors and additionally represented companies must be registered on a separate form by the main exhibitor.

If, during the fair, the Exhibition Management finds co-exhibitors/additionally represented companies that have not been registered, a surcharge of ₹15,000 + tax must be paid.

A 4. Co-exhibitors and additionally represented companies

A co-exhibitor is one who presents his own goods or services, using his own staff on the stand of another exhibitor (the main tenant). This definition includes group companies and subsidiaries. Agents and representatives are not admitted as co-exhibitors.

In the case of an exhibitor who manufactures in his own right, an additionally represented company is any other company whose goods or services are offered by the exhibitor.

If an exhibitor, who is a distributor, displays not only the products of one manufacturer but also the goods and services of other companies, then these count as additionally represented companies.

Admission of the exhibitor does not mean that a contract has been concluded between the co-exhibitors registered by him for participation or other companies he additionally represents and Messe Muenchen India. The participation of co-exhibitors is only allowed if they have been admitted for participation by Messe Muenchen India.

The participation of companies as additionally represented companies is only allowed if this is foreseen in the Special Terms of Participation B and they have been admitted for participation by Messe Muenchen India.

Co-exhibitors and additionally represented companies may only be admitted for participation by Messe Muenchen India if they have qualified for admission as exhibitors in their own right. The participation of co-exhibitors and the participation of companies as additionally represented companies is then subject to payment of the relevant charges if this is required by the Special Terms of Participation B. The charge for co-exhibitors and additionally represented companies is payable by the given exhibitor; it can also be invoiced subsequently by Messe Muenchen India after the trade fair is over.

The exhibitor is responsible for ensuring that his co-exhibitors and other companies he represents comply with the Terms of Participation A and B, the Technical Guidelines as well as the instructions of the Trade Fair Management. The exhibitor is liable for the debts and negligence of his co-exhibitors or additionally represented companies as if they were his own. If co-exhibitors make direct use of Messe Muenchen India services by submitting the required application form, Messe Muenchen India is entitled to invoice the exhibitor for these services. The exhibitor is jointly and severally liable.
